BOARD ACTION REQUESTED:

Approval of a Constituent Relations Representative

BACKGROUND:

Historically, our office has not had an engagement plan with the public that furthers the County's priority of an Inclusive & Collaborative Culture. Typically, we have taken a reactive approach to constituent services and engagement. As a result, residents have not always had an effective link to their elected representatives and the services they need. Each Commissioner represents over 45,000 residents with almost no staff support.

DISCUSSION:

In creating this position, our office looks to focus on three specific areas: First Point of Contact, In-person Public Engagement, and Public Sentiment Monitoring. This role will serve as the initial connection between Genesee County residents and the Board of Commissioners, as well as other county departments, commissions, and committees. By streamlining this communication, we can ensure that residents receive the assistance they need promptly when reaching out to the Board Office. In coordination with the Director of Communications, the representative would be tasked with responding quickly and effectively to public inquiries, and feedback through various communication channels. This responsiveness is vital in fostering trust and transparency within our community between residents and commissioners. The representative will also develop, plan and coordinate events designed to enhance public engagement with Genesee County's programs, service and board-led initiatives. These events will serve as opportunities to build relationships and provide residents with valuable information. Finally, the representative would also monitor and report on public sentiment regarding county services. By utilizing these insights, we could refine our communication and engagement strategies to better meet the needs and expectations of our constituents. In short, this position will create new engagement opportunities between Genesee County residents and the Board to better position the Board as a prime mover of positive change in Genesee County.

BACKGROUND:

Per the prior approved resolution; G.H.O.S.T. is Committed to combat human oppression in both human trafficking and the opioid epidemic. The LPR system tracks vehicles as they travel across county from high trafficking areas. The LPR system collects this information and will allow G.H.O.S.T. to begin their investigation as the traffickers arrive. This LPR system allows the Sheriff's Office access to real time actionable intelligence. This LPR system is the only system that is connected with Homeland Security and Border Patrol.

DISCUSSION:

The prior vendor was approved to Vigilant Solutions, LLC which has been acquired by Motorola. All prior Reso references, including the funding Reso 2023-725 has all been provided in the attachments with this request, including the acquisition notice from Vigilant to Motorola Solutions.

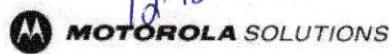

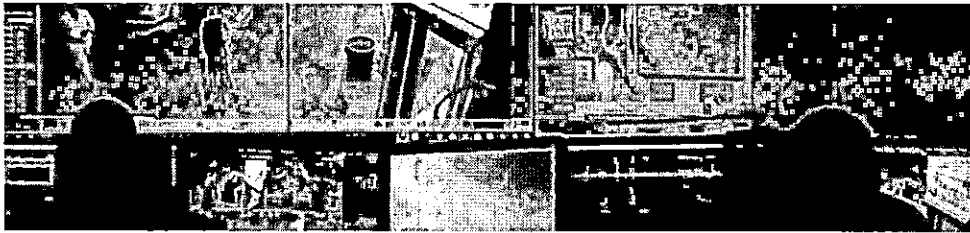

RE: Legal Resource Center Furniture

BOARD ACTION REQUESTED:

approve the request to order furniture for the Legal Resource Center and Legal Records Division from Pinnacle Design in the amount of \$62,806.93.

BACKGROUND:

The former law library has been deconstructed and the space re-purposed for the Genesee County Legal Resource Center. Project completion date is March 25, 2025. The former law library featured 2 offices with 20+year old mis-matched metal furniture. The items were returned to the county for further disposition. The bookshelves were sold through Genesee County Purchasing and the hard volume law library re-cycled. The intentional design of the LRC is to provide greater public access to legal resource materials with staff to assist, in a welcoming environment intended to better serve our community.

DISCUSSION:

The design of the LRC will include public use space with either built in desk level work surfaces or desks suitable for short term, intermittent use. The offices will require a task chair and, in limited locations, 2 additional seats for accompanying visitor support or group consultation. At the informational kiosk locations, only 1 task chair is required. There will be 4 fulltime staff offices that require more conventional office furnishings to support daily work activity, including the personal protection and emergency response protection order (PPO/ERPO) point of filing for the Legal Records Division. This is a 100% electronic workflow protocol. The multi-use conference room will feature a large table that was procured at no expense and chairs sufficient to conduct mid-large size group meetings, walk-in clinics, mediation sessions, civil case evaluation and staff training. The infrastructure will be in place for remote connectivity for expanded use. In the Legal Records Division, there are 2 fulltime managers. Only 1 office existed. Therefore, 1 office was added as part of the project. Furnishings for the office are included in this request.
