Now, please accept this correspondence in response to your FOIA request (**#25-510**) submitted to Genesee County's FOIA Specialist and deemed officially received on May 9, 2025. A 10-day extension was submitted as permitted by section 5(2)(d) of the FOIA, MCL 15.235(2)(d).

I understand your FOIA request to be for a copy of the ***"police incident report (No: 2512501149) pertaining to your client, William Pinkenburg, who was involved in an automobile accident on 03/29/2025 at NB-I75 & Vienna Road, Vienna Twp., MI."***

Please know that in responding to your FOIA request, I relied upon and received information from Lieutenant Nicklesen of the Sheriff's Office.

Your FOIA request is granted in-part and denied in-part.

Nicklesen, I hereby certify. You are further advised that you have the right to seek judicial review of such denial and obtain attorney's fees and damages to the extent provided in, and subject to the conditions of, section 10 of the FOIA ("Section 10"). A copy of Section 10 is uploaded to the portal and is incorporated in this response by reference.
