

AMENDMENT and EXTENSION to Professional Services Agreement
With Genesee Health System

This Amendment and Extension is between Genesee Health System (“GHS”) and the County of Genesee, a Michigan municipal corporation whose principal place of business is located at 324 South Saginaw Street, Flint, Michigan 48502 (the “County”), acting through the 7th Judicial Circuit Court, Family Division (the Contractor and the County together, the “Parties”), as an Amendment and Extension to the underlying agreement entered into between the Parties, reflected in Resolution # 2024-1228, for multisystemic therapy services.

WHEREAS, the Parties executed a contract, effective October 1, 2024 – September 30, 2025 (the “Agreement”), pursuant to which the Contractor would perform multisystemic therapy services; and

WHEREAS, the Parties wish to amend the underlying Agreement to incorporate expanded therapy services, to include anger management therapy/services and trauma therapy/services;

WHEREAS, the Parties wish to extend the Agreement, incorporating the amendment for anger management and trauma therapy/services, for an additional year, as specified in Paragraph 1.2 of the underlying Agreement.

NOW THEREFORE, the Parties agree as follows:

1. The Agreement shall be amended to include anger management therapy/services and trauma therapy/services, to wit:

Paragraph 3. Compensation shall be amended, in part, as follows:

The total value of the contract is not to exceed \$340,000. The total contract amount for the Multisystem Therapy services is not to exceed \$275,000. The total contract amount for the anger management and trauma therapy/service is not to exceed \$65,000.

Paragraph 16.1 Entire Contract shall be amended, in part, as follows:

16.1.2. *Exhibit A – The Scope of Work – Multisystem Therapy*

16.1.3. *Exhibit B – The Scope of Work – Anger Management and Trauma Therapy*

Exhibit B shall be added to the Agreement, to incorporate the Scope of Work for anger management and trauma therapy services. Exhibit B reads as follows:

EXHIBIT B

Description of the Services

Eligibility criteria: Juvenile court-involved youth, ages 12-17 at the time of the alleged involvement, presenting with suspected mental illness for which group therapy treatment(s) may be beneficial will be eligible for an assessment with Genesee Health System (GHS). If deemed eligible and appropriate, youth will participate in evidenced-based groups that focus on trauma and/or anger management based on their needs. Services to offenders that were under the age of 18 at the time of court involvement may be provided past the age of eighteen in certain circumstances where the Court has lawfully extended its jurisdiction beyond age 18.

File documentation required: GHS is required to have the following documents available in its electronic file for each youth assigned to group therapy:

- Face sheet with demographics
- Petition and any subsequent petitions
- Court order into Trauma/Anger Management program
- Case assessment and treatment plan
- Progress notes
- Periodic reviews
- Discharge summary including where youth will reside

Services provided following written court referral:

- Clinical assessment(s) – intake biopsychosocial assessment, MichiCANS, or other appropriate assessment tool(s)
- Group therapy, incorporating CBT
- Individual/family therapy sessions to follow trauma group completion as deemed necessary per trauma assessment result post-group, as part of TFCBT evidenced-based practice model.
- Quarterly periodic review
- Transition and/or discharge planning; may include referral to additional services at GHS or in community

Program length: 3-6 months per youth

Reporting: Monthly attendance sheets, attached to invoices

Billing: Medicaid and health plans will be billed for all billable services; this agreement includes only services that are NOT billable.

The Contractor will provide the County with monthly invoices in a form acceptable to the County along with any necessary supporting documentation, such as time sheets and attendance sheets. The invoices will be submitted no later than the 10th of the month following the close of the month of service.

Late invoices, those submitted any time after the 10th day of the month following the close of the month of service, will not be paid. If the Contractor submits a late invoice,

the invoice may be paid at the discretion of the Contract Administrator only after written notice from the Contractor stating the reason for the late invoice.

The County Administrator shall be the point of submission for the monthly invoices. The request for payment will be placed in line for payment as soon as practical and consistent with the current practice. The County will pay the Contractor within sixty (60) days of the County's acceptance of the invoice and supporting documentation.

The billing invoice shall include the following:

- Billing month
- Youth name
- Date of birth
- Age
- Court case number(s)
- Service date(s)
- Service type(s)
- Service rate(s)
- Total amount for the entire invoice

2. The Agreement, as herein amended and incorporated above, shall be extended for October 1, 2025 – September 30, 2026.
3. The remaining terms of the Agreement remain unchanged and in full effect.
