TO THE HONORABLE CHAIRPERSON AND MEMBERS OF THE GENESEE COUNTY BOARD OF COMMISSIONERS, GENESEE COUNTY, MICHIGAN

#### LADIES AND GENTLEMEN:

WHEREAS, this Board of County Commissioners of Genesee County, Michigan ("Board"), authorized the establishment of a system or systems of water, sewer, or sewage disposal improvements and services in accordance with Public Act 341 of 1939; and

WHEREAS, after authorizing the establishment of this public improvement, this Board designated the Genesee County Drain Commissioner ("Drain Commissioner") to act as the County Agency for said public improvement; and

WHEREAS, the Drain Commissioner created the Division of Water and Waste ("Division") to meet the needs of the County Agency; and

WHEREAS, the Division has determined that it has excess property, specifically parcel 06-19-300-022 in Fenton Township; and

WHEREAS, the Division desires to sell excess land on said parcel to Fenton Township; and WHEREAS, the Division and/or the County Agency needs this Board's permission before it can sell said excess land.

NOW, THEREFORE, BE IT RESOLVED, by this Board of County Commissioners of Genesee County, Michigan, that the request by the Deputy Drain Commissioner to grant the Drain Commissioner, as the County Agency, permission to sell excess land on parcel 06-19-300-022 in Fenton Township to Fenton Township, is approved (a copy of the memorandum request being on file
