NOTICE OF PROPOSED SOLE SOURCE PROCUREMENT #24-41?

The Genesee County Procurement Regulations provides that a procurement may be made without competition when there is only one source for the required supply or service. Therefore, a "sole source" procurement is justified if there is only one product or service that can reasonably meet the county's need and there is only one vendor who can provide the product or service.

The Purchasing Department has received a request to make the following sole source procurement:

- Work with parent(s)/guardian(s)/caretaker(s) to coordinate visitation between children and their incarcerated parent.
- Provide staff to oversee child visitation days. Staff will complete check-ins, assist with searches of minor children, escort children to visiting area, and oversee engagement of parent(s) and children during visit.

NOTICE OF PROPOSED SOLE SOURCE PROCUREMENT:

The Genesee County Sheriff's Office has contracted with Motherly Intercession since June 2024 to provide inmates of the Genesee County Jail with parenting classes for inmates, visitation, and supportive services.

Purpose of This Notice of Proposed Sole Source Posting:

The intent of this posting is to verify with the vendor community that this proposed purchase is indeed a valid sole source.

Sole Source Criteria:

- 1. The product or services being purchased must perform a function for which no other product or source of services exist:
 - Motherly Intersession is a 501(c)(3) nonprofit organization in Flint and Genese County. Motherly Intersession provides services for children and families who are experiencing or previously experienced parental incarceration. Their mission is to empower children to break the cycle of intergenerational incarceration.
- 2. The purchaser must be able to show specific business objectives that can be met only through the unique product or services:

Motherly Intercession offers the following services

- Survey in-custody inmates to determine eligible children.
- Conduct face-to-face interviews of inmates to collect the children's names and ages as well as the contact information for the parent(s)/guardian(s)/caretaker(s)
- Communicate with Genesee County Sheriff Office staff to confirm any court orders or restrictions preventing the inmate from having a contact visit with their child.
- Contact parent(s)/guardian(s)/caretaker(s) to gain consent for the child to attend a contact visit with the incarcerated parent.
- Verify parental rights.
- Confirm with Genesee County Sheriff Office staff the inmate(s) location and eligibility for in-person visit.
- Staff is present every other Saturday from 8:00 AM until visits are completed 2:00 3:00 PM. During this time, they complete check-ins, assists with searches of minor children, escort children to the visiting area, and oversee the engagement of parent(s) and children during the visit.

Action to be Taken: No action is required if you agree this request for services has validity as being a sole source.

Response from Objecting Parties
