Overview

Opioid Settlements Overview

- By 2017 numerous federal lawsuits were filed against opioid distributors, manufacturers, marketers, and retailers for their role in the opioid epidemic; these were consolidated by a federal judicial panel into multidistrict litigation
- The Michigan Department of Attorney General and multiple local governments filed lawsuits
- In 2019, the first settlements were reached (there are approximately 17 settlements to date)
- Eligible local governments had the ability to sign-on to participate in settlements; this includes signing a State-Subdivision Agreement associated with how funds will be used
- Local governments in Michigan began receiving funds in January of 2023



Genesee County Overview

- From 2018-2022, Genesee County had a rate of 49.9 overdose fatalities per 100,000 people, the highest rate in the state
- From 2020-2022, Genesee County had a rate of 397.8 nonfatal overdose emergency department visits per 100,000 people, the 5th highest rate in the state
- Participating local governments within the County:

 - Davison Township
 - Fenton Charter Township

 - Flint Charter Township

Expected Funds

- Michigan expected total: \$1,665,509,773
 - Total estimated state share: \$ 919,280,688
 - Total estimated subdivision share: \$ 745,562,275
 - Funds are to be paid out over 18 years
- Genesee County expected total: \$13,378,219.63
- Genesee County has received approximately: \$7,040,079.82



Spending Requirements

- All funds are intended to be used on opioid remediation; may not be used for general fund expenses
- The settlements documents and Michigan State-Subdivision Agreement require a minimum of **70**% of Settlement Payments to be used solely for **future remediation** (activities that have not yet taken place)



Spending Requirements

• Expenditures must align with both <u>Exhibit E</u>, the list of allowable uses, and the legal definition of opioid remediation

Opioid Remediation:

Care, treatment, and other programs and expenditures (including reimbursement for past such programs or expenditures except where this Agreement restricts the use of funds solely to future Opioid Remediation) designed to

- (1) address the misuse and abuse of opioid products,
- (2) treat or mitigate opioid use or related disorders, or
- (3) mitigate other alleged effects of, including on those injured as a result of, the opioid epidemic




Exhibit E Overview

- Settlements outline specific strategies for utilization of funds, including:
 - Prevention
 - Harm Reduction
 - Treatment
 - Recovery
 - Focus on those most profoundly impacted
 - Avoid expenditures that are punitive or coercive in nature
