

AMENDMENT TO Meridian Remonumentation Services Contract

This Amendment is effective January 1, 2026, and is between Genesee County, Michigan, a Michigan municipal corporation whose principal place of business is located at 324 S. Saginaw St, Flint, Michigan 48502 (the "County"), and Meridian Land Surveying, Inc., a Michigan Corporation, whose principal place of business is located at 940 S. Grand Traverse, Flint, MI 48502 (the "Contractor") (the Contractor and the County together, the "Parties").

WHEREAS, the Parties executed a Remonumentation Contract effective 9/25/2025 (the "Agreement"), pursuant to which the Contractor would perform remonumentation services; and

WHEREAS, the Genesee County Board of Commissioners authorized the original Meridian Remonumentation Services Contract by Resolution # RES-2025-2235; and

WHEREAS, the Parties wish to amend the Agreement to include a new set of corners and associated fees for the 2026 Grant.

NOW THEREFORE, the Parties agree as follows:

1. The agreement shall be extended for the period of January 1, 2026 through December 31, 2026.
2. The following 23 corners are to be surveyed and monumented in calendar year 2026:
